Subject: Proposed 2022 Food Service (FSO) and Retail Food Establishment (RFE) License Fees and Public Hearing Notice

On September 14, 2021 the Middletown Board of Health will conduct a public hearing in accordance with Chapter 3717.25 and 3717.45 of the Ohio Revised Code in regard to the proposed FSO and RFE license fees to become effective on December 1, 2021. The public hearing will be held on Tuesday, **September 14** at 7:30 a.m. in Conference Room 2C on the second floor of the City Building, One Donham Plaza, Middletown, Ohio 45042. Comments will also be accepted in writing prior to the hearing. The proposed FSO and RFE license fees for 2022 are as follows:
